Bill No. 28-0233 – An Act to rezone Plot Nos. 341, 342, 343, and 344 Estate Enfield Green, Prince Quarter, St. Croix from R-3 (Residential-Medium Density) to B-3 (Business-Scattered)

Bill No. 28-0149 – An Act amending title 5 V.I.C., adding chapter 345 to establish the Virgin Islands DNA Database and Databank

Bill No. 28-0177 – An Act amending the Virgin Islands Code titles 14, chapter 13, title 16, chapter 2, and title 24, chapter 28 Virgin Islands Code, relating to the protection of victims of domestic violence, and enacting The Domestic Violence Prevention Act of 2010

Bill No. 28-0202 – An Act amending 24 V.I.C., chapter 18 relating to plant closings, amending 16 V.I.C., § 378 (g) relating to penalties for employers' failure to report hiring or employees

Bill No. 28-0203 – An Act amending 3 V.I.C., §415 & 27 V.I.C., §3 as it relates to the composition of the Board of Medical Examiners

Bill No. 28-0215 – An Act amending 14 V.I.C., chapter 113, and V.I.C., chapter 5, respectively relating to the lawful possession of firearms ammunition and requirements for licensed dealers of firearms and ammunition

Bill No. 28-0220 – An Act amending Act No. 7103 relating to an appropriation for Massac Nursing Home and making appropriations to the Department of Human Services for the Meals on Wheels Program and the purchase of Medical Alert Bracelets and to the Department of Health for the Home Health Program

Bill No. 28-0221 – An Act appropriating \$40,000 to VITEMA to identify tsunami escape routes and for other tsunami purposes

Bill No. 28-0224 – An Act amending title 33 Virgin Islands Code, chapter 89, section 2495 -relating to notices of payment due for real property taxes and public sewer user fees

Bill No. 28-0157 – An Act amending 3 V.I.C., removing the jurisdiction of the Virgin Islands Drug Enforcement Bureau from the Office of the Governor by renaming and creating a new semiautonomous agency within the Executive Branch of the Government of the Virgin Islands to be known as “The Virgin Islands Bureau of Narcotics and Dangerous Drug Control”

Bill No. 28-0164 – An Act amending 24 V.I.C., chapter 14, to increase the number of members of the PERB Board and establish a fine for willful or malicious violations of its orders by public employers

Bill No. 28-0173 – A Resolution requesting the Department of Health to study the feasibility and cost of the operation of a mobile dental health clinic

Bill No. 28-0185- An Act repealing and reenacting title 28 Virgin Islands Code, chapter 29 to enact the Virgin Islands Uniform Fraudulent Transfer Act

Bill No. 28-0231 – An Act designating Lindberg Bay an area of particular concern

Bill No. 28-0240 – An Act correcting the zoning designation in Act 7164 from B-4 to B-2

Bill No. 28-0174 – An Act that establish nutrition standards for foods sold outside of the federal meal program, and also makes nutrition standards consistent across the Virgin Islands

Bill No. 28-0034 – An Act authorizing the Government of the Virgin Islands to purchase Plot No. 14 AB North Hall. West End Quarter for conservation purpose (**Subject to the Approval of the Committee on Appropriations and Budget**)

Bill No. 28-0100 – An Act appropriating \$15,000,000 to the Virgin Islands Department of Education to develop and construct a school for the creative and performing arts on the island of St. Croix (**Subject to the Approval of the Committee on Appropriations and Budget**)

Bill No. 28-0217 – An Act appropriating \$40,000 to the Department of Public Works to design and construct public restroom and bench facilities in downtown Christiansted, St. Croix (**Subject to the Approval of the Committee on Appropriations and Budget**)

Bill No. 28-0247 – An Act appropriating \$15,000 from the General Fund of the Government of the Virgin Islands in fiscal year ending September 30, 2011, to the Ronald Charles Basketball League on the island of St. Croix (**Subject to the Approval of the Committee on Appropriations and Budget**)
