Sending a Letter

The letter is the most common method for communicating with legislative offices. If you choose to write a letter, the following list of suggestions will improve your communication:

- The purpose of your communication should be stated in the first paragraph of the letter. If your letter concerns a specific piece of legislation, identify it accordingly (e.g., Bill Number: _____).
- Address only one issue in a letter and, if possible, keep your letter to the length of one page.

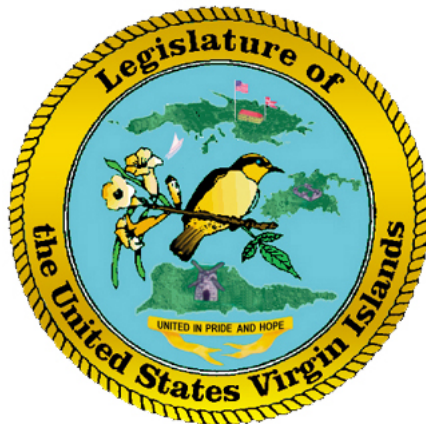

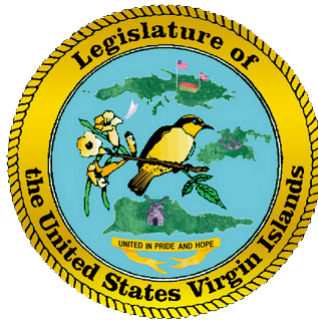
