- 2 Agriculture executed the Lease Agreement between the Government of the Virgin Islands and
- 3 James O. Gaston;
- 4 WHEREAS, on October 19, 2023, the Commissioner of the Department of Property and
- 5 Procurement executed the Lease Agreement between the Government of the Virgin Islands and
- 6 James O. Gaston;
- WHEREAS, on October 26, 2023, the Governor of the Virgin Islands approved the
- 8 Lease Agreement between the Government of the Virgin Islands and James O. Gaston;
- 9 WHEREAS, James O. Gaston, will be leasing Plot No. 9-G VICORP Lands, Prince
- Quarter, St. Croix, Virgin Islands, consisting of approximately 653, 400 U.S. sq. ft. or 15 U.S.

- acres of unimproved land, more or less, as shown on Drawing No. A9-5-C008; for an initial
- 2 term of 20 years, with a 10-year option to renew; at an annual rent of \$225.00, to be used for
- 3 crop production and rearing small livestock;
- 4 WHEREAS, title 31 Virgin Islands Code, chapter 21, section 205, subsection (c)
- 5 provides that in addition to the Governor's approval of any lease, the Legislature of the Virgin
- 6 Islands must also approve all leases that exceeds a term of one year; Now, Therefore,
- 7 Be it enacted by the Legislature of the Virgin Islands:
- 8 **SECTION 1.** Pursuant to title 31 Virgin Islands Code, section 205, subsection (c), the
- 9 Legislature of the Virgin Islands approves the Lease Agreement between the Government of
- 10 the Virgin Islands, acting through its Commissioner of the Department of Property and
- 11 Procurement and James O. Gaston, for Plot No. 9-G VICORP Lands, Prince Quarter, St. Croix,
- 12 Virgin Islands, consisting of approximately 653, 400 U.S. sq. ft. or 15 U.S. acres of unimproved
- land, more or less, as shown on Drawing No. A9-5-C008; for an initial term of 20 years, with
- a 10-year option to renew; at an annual rent of \$225.00, to be used for crop production and
- 15 rearing small livestock.
